With a population of 323 million, this country produces a quarter of the world's gross domestic product (GDP).

Moreover, as the first military power, U. S. troops and fleets are spread throughout all strategic areas of the globe. Nevertheless, since many people have partial knowledge of this country, they often have misconceptions and stereotypes about it.
